# **SCOPE OF WORK:**

# Selected vendors will be expected to:

- Provide a variety of fresh fruits and vegetables, emphasizing locally sourced produce when possible.
- Set up, manage, and dismantle their stalls in the designated area within the community retail space once a week (schedule determined by vendors).
- Comply with all local health and safety regulations regarding the handling and sale of food products.
- Participate in promotional activities organized by Paradigm Place to market the weekly event.

# **PROPOSAL REQUIREMENTS:**

# Vendors interested in participating should submit a proposal that includes:

- **Company Overview:** A brief history of your business, including years of operation, mission, and values.
- **Product List:** A detailed list of fruits and vegetables you plan to offer, including any specialty or seasonal items.
- **Sourcing Information:** Information on how your produce is sourced, with an emphasis on local and organic products.
- **Experience and References:** Description of previous experience in similar markets or events, including references (optional).
- Operational Plan: A brief outline of your logistics plan for weekly setup, sales, and breakdown.
- **Pricing Structure:** An overview of your pricing strategy, including any proposed discounts for regular purchases or large orders.

# TERMS AND CONDITIONS FOR RFP: PROVISION OF FRUITS AND VEGETABLES FOR COMMUNITY RETAIL SPACE

1. Introduction: These Terms and Conditions govern the submission of proposals in response to the Request for Proposal (RFP) issued by Paradigm Place (A Paradigm Global Innovations Company) for the provision of fruits and vegetables at the new community retail space. By submitting a proposal, the Vendor agrees to be bound by these Terms and Conditions.

# 2. Proposal Submission

- Proposals must be submitted by the deadline specified in the RFP.
